

SPREDDITOR INFLUENCER TERMS & CONDITIONS AGREEMENT

This Influencer Terms & Conditions Agreement (“Agreement”) is entered into between Spredditor (“Company/Client”) and the individual registering or performing influencer services (“Influencer” or “Creator”). By signing this Agreement or accepting these Terms electronically, the Influencer agrees to comply with all obligations mentioned herein.

1. ELIGIBILITY

- The Influencer must be at least 18 years old.
- All Reddit accounts used must be legitimately owned or controlled by the Influencer.
- The Influencer must comply with Reddit policies and subreddit rules.

2. SERVICES

The Company/Client may engage the Influencer for Reddit-based activities including posting, commenting, engagement, discussions, upvoting, and campaign-based promotions. Campaign instructions may be shared through briefs, messages, or email.

3. INFLUENCER RESPONSIBILITIES

The Influencer agrees to perform all services professionally and authentically and shall not:

- Use bots or automated engagement tools
- Engage in spam or artificial manipulation
- Post unlawful or misleading content
- Violate Reddit policies or subreddit rules

4. CONFIDENTIALITY

All campaign information, client details, strategies, payment structures, and internal business information shared by the Company/Client shall remain confidential. The Influencer shall not publicly disclose their association with the Company/Client unless authorised in writing.

5. INTELLECTUAL PROPERTY

All deliverables, posts, comments, reports, screenshots, and campaign materials created for the Company/Client shall become the sole property of the Company/Client.

6. PAYMENTS

6.1 Compensation shall be communicated separately for each campaign.

6.2 Payments may vary depending on account metrics, engagement quality, and campaign performance.

6.3 Payments shall be processed after verification and approval of deliverables.

6.4 The Company/Client reserves the right to reject non-compliant deliverables.

6.5 Influencers shall only be eligible for payment if approved posts, comments, or campaign deliverables remain active and publicly visible for the duration specified by the Company/Client.

6.6 If an Influencer intentionally deletes, edits, archives, or removes any approved campaign-related post or comment without prior written approval, the Influencer must immediately notify the Company/Client and may be required to refund any payment received for such deliverables.

6.7 The Company/Client reserves the right to withhold or recover payments for deleted, removed, non-compliant, or unavailable deliverables.

7. PROHIBITED ACTIVITIES

The Influencer shall not:

- Use fake or illegally acquired accounts
- Contact Company/Client clients directly
- Share the identity of other creators engaged by the Company/Client
- Use bots, vote manipulation, or coordinated inauthentic behaviour
- Promote illegal or harmful products or services

8. TERMINATION

The Company/Client may suspend or terminate the Influencer's engagement for violations of this Agreement, Reddit policy violations, misconduct, or breach of confidentiality.

9. INDEPENDENT CONTRACTOR STATUS

The Influencer is engaged as an independent contractor and not as an employee, partner, or agent of the Company/Client.

10. LIMITATION OF LIABILITY

The Company/Client shall not be liable for Reddit account bans, platform changes, loss of earnings, service interruptions, or indirect damages.

11. GOVERNING LAW

This Agreement shall be governed by the laws of India. Any disputes shall fall under the jurisdiction of Bengaluru, Karnataka.

12. GENERAL TERMS

Electronic acceptance, digital signatures, and scanned signatures shall be considered legally valid.

By registering on Spredditor, accessing the platform, or participating in campaigns, the Influencer confirms that they have read, understood, and agreed to these Terms & Conditions.
